**Disclosure under Regulation 30 of SEBI (Listing

As the novel Coronavirus (COVID-19) outbreak continues to spread rapidly across the world and India, at The Tinplate Company of India Limited, our first and foremost priority is the health and safety of our employees and the communities in which we operate. We aim to run our operations safely and efficiently so that we can continue to service our customers to the extent practical. We also remain focused on conserving cash and ensuring we have adequate liquidity. Further to the above, you are aware, the Government of India and State Governments, in order to control the spread of COVID – 19, have also imposed lock down and several restrictions throughout the Country.

Keeping in mind the above, the practical constraints of continuing operations and dispatches and the safety & health of our employees & other stakeholders, the Company has suspended its operation of certain facilities at its plant in Jamshedpur, Jharkhand till the situation improves. Consequent to the suspension of the facilities as stated above, the production of finished goods have significantly reduced. However, the Company, considering that work in progress stock have limited shelf life, continues to operate both the tinning lines with minimum staff to convert the available work in progress stock into finished goods till such stock gets exhausted.

The overall adverse impact on the operations of the Company due to suspension and expected financial impact, is not immediately ascertainable at this stage. The Company is closely monitoring the situation and taking appropriate actions as per the directions issued by the regulatory authorities from time to time keeping in view the interests of the Company, health and safety of employees and other stakeholders. The Company will resume its normal operations as soon as the situation improves and permits.
